Keyingi yillarda mamlakatimiz hayotining barcha soha va tarmoqlarini XXI asrning yuksak demokratik talablari asosida yangilash, inson huquq va erkinliklari, manfaatlarini ta'minlash, jahon hamjamiyati bilan uyg'un va hamnafas bo'lib yashash, milliy tiklanishdan milliy yuksalishga erishish yo'lida ulkan ishlar amalga oshirilmoqda. Ana shunday strategik maqsadlarning eng muhim uzviy qismi bo'lgan ilm-fan va ta'lim-tarbiya tizimini, jumladan oliy ta'lim taraqqiyotini yangi bosqichga ko'tarish ustuvor masala sifatida kun tartibiga qo'yilmoqda.

Ayni shu asosda insonning fundamental huquqlaridan biri bo'lgan bilim olish, zamonaviy kasb-hunarlar, malaka darajalarini egallash bo'yicha katta imkoniyatlar yaratilmoqda.

Qisqa muddatda respublikamizda oliy ta'lim muassasalari soni qariyb ikki barobar oshgani, bozor iqtisodiyoti talablaridan kelib chiqqan holda, yangi oliygohlar, xususan nufuzli xorijiy universitetlarning filiallari ochilayotgani, tizimda o'qishning kunduzgi shakli bilan birga kechki va sirtqi bo'limlar faoliyati yo'lga qo'yilgani, maktab bitiruvchilarining oliy ta'lim muassasalariga qamrovi 2016-yildagi 9 foizdan bugungi kunga kelib 28 foizga yetganini alohida ta'kidlash lozim.

Shu bilan birga, bugungi kunda biz o'z oldimizga qo'ygan, har tomonlama rivojlangan yangi O'zbekiston davlati va jamiyatini barpo etish, Uchinchi Renessans poydevorini yaratishdek ulkan vazifalar yurtimizda yuksak intellektual salohiyatga ega bo'lgan, jahon mehnat bozori, ilm-fan va texnologiyalar olamida raqobatdosh, zamonaviy bilim va ko'nikmalarni

**RESOLUTION PRESIDENT OF THE REPUBLIC OF
UZBEKISTAN**

**ON THE ESTABLISHMENT OF THE UNIVERSITY NEW
UZBEKISTAN**

In recent years, large-scale work has been carried out on the path to renewing all spheres and sectors of the country's life based on the high democratic demands of the 21st century, ensuring human rights, freedoms and interests, coexistence in harmony and agreement with the world community, from national revival to achieving national progress. Raising the system of science, education and upbringing to a new level, including the development of higher education, as the most important integral part of the designated strategic goals, is put on the agenda as a priority task.

It is on this basis that great opportunities are created for acquiring knowledge, mastering modern professions and qualification levels, which are one of the fundamental human rights.

It should be especially emphasized that in a short period of time the number of higher educational institutions in the republic has exceeded two thousand, based on the requirements of the market economy, new higher educational institutions are being created, in particular, branches of prestigious foreign universities are being opened, along with full-time education, the system has also established the activities of evening and correspondence departments, the coverage of school graduates by higher educational institutions has reached 28 percent today from 9 percent in 2016.

At the same time, the lofty goals we have set, such as building a comprehensively developed state and society in the new Uzbekistan and creating the foundation for the Third Renaissance, require further qualitative strengthening of work on the formation in the country of an

chuqur o'zlashtirgan, yuqori malakali, mustaqil fikrlaydigan, vatanparvar kadrlar tayyorlashning umume'tirof etilgan xalqaro standartlar asosidagi innovatsion tizimini shakllantirish borasidagi ishlarimizni sifat jihatidan yanada kuchaytirishni talab etmoqda.

Bunda, hech shubhasiz, mamlakatimiz oliy ta'lim tizimining bayroqdori — flagmani sifatida respublikamiz va dunyo tajribasining eng ilg'or yutuqlarini o'zida mujassam etadigan, barcha institut va universitetlarimizga namunaviy model bo'lib xizmat qiladigan yangi zamonaviy universitetni tashkil etish muhim ahamiyatga egadir.

Xalqimiz, avvalo, yoshlarimizning talab va istaklarini hisobga olib hamda mamlakatimizning oliy ta'lim sohasidagi kadrlar tayyorlash salohiyatini oshirish, bu borada farzandlarimiz uchun yanada keng imkoniyat va sharoitlar yaratish maqsadida:

1. Mamlakatimiz poytaxti Toshkent shahrida “Yangi O'zbekiston” universiteti (keyingi o'rinlarda — Universitet) tashkil etilsin.

Belgilansinki:

Universitet davlat oliy ta'lim muassasasi hisoblanadi;

Universitetda ta'lim jarayoni nufuzli xorijiy oliy ta'lim muassasalari bilan hamkorlikda tashkil etiladi;

Universitetni tamomlagan O'zbekiston Respublikasi fuqarolari Davlat xizmatini rivojlantirish agentligi tomonidan Milliy kadrlar zaxirasiga olinadi hamda 5 yillik ish tajribasidan so'ng rahbarlik lavozimiga tayinlanadigan istiqbolli nomzodlar ro'yxatiga kiritiladi;

Universitet O'zbekiston Respublikasi Davlat gerbi tasviri va davlat tilida nomi tushirilgan muhr, bank hisobvaraqlari, shtamp va boshqa rekvizitlariga ega bo'ladi.

2. Quyidagilar Universitetning asosiy vazifalari etib belgilansin:

innovative system for training highly qualified, independently thinking, patriotic personnel with high intellectual potential, competitive in the international labor market, in the field of science and technology, who have deeply mastered modern knowledge and skills, based on generally recognized international standards.

The creation of a new modern university as a flagship of the higher education system of Uzbekistan, embodying the most advanced achievements of national and international experience, serving as an exemplary model for all institutes and universities, is of course of great importance.

Taking into account the demands and wishes of the people, especially the youth, in order to increase the country's potential for training personnel in the field of higher education, as well as creating broader opportunities and conditions for our children in this area:

1. To establish the New Uzbekistan University (hereinafter referred to as the University) in the capital of our country, Tashkent.

Establish that:

The University is a state higher educational institution;

At the University, the educational process is organized in cooperation with prestigious foreign higher educational institutions;

citizens of the Republic of Uzbekistan who graduated from the University are included in the National Personnel Reserve by the Civil Service Development Agency, and after acquiring five years of work experience, they are included in the list of promising candidates appointed to leadership positions;

nufuzli xorijiy oliy o'quv yurtlarining ta'lim dasturlari asosida yuksak zamonaviy kasbiy bilim va malakaga ega bo'lgan, xalqaro miqyosda raqobatbardosh, istiqbolli kadrlarni tayyorlash;

o'quv-tarbiya jarayonini ilg'or pedagogik va zamonaviy axborot texnologiyalarini qo'llagan holda jahonning yetakchi universitetlarida joriy etilgan ta'lim texnologiyalari va usullari asosida tashkil etish;

talabalarning intellektual qobiliyatini rivojlantirish, bilimni amaliy tajribalar orqali mustahkamlashga, o'quv materiallarini samarali va puxta o'zlashtirishga xizmat qiladigan har tomonlama qulay ta'lim muhitini shakllantirish;

ijtimoiy-iqtisodiy sohalaridagi mavjud ehtiyojlardan kelib chiqib, ilmiy-tadqiqot ishlarini olib borish, shuningdek, chet ellardagi nufuzli, tan olingan ilmiy markazlar bilan yaqindan hamkorlik qilish, talabalarni ilmiy va innovatsion faoliyatga keng jalb etish;

ta'limning uzluksizligi va sifatini ta'minlash borasida Prezident maktablari, ijod va ixtisoslashtirilgan maktablarga metodik yordam ko'rsatish.

3. Belgilab qo'yilsinki:

a) Universitet quyidagilarni mustaqil ravishda amalga oshiradi:

Universitetning tuzilmasini va shtatlar jadvalini tasdiqlash, shuningdek, bakalavriat va magistraturada o'qish tartibini belgilash;

xorijiy oliy ta'lim muassasalari bilan tuzilgan kelishuvlar asosida ta'lim yo'nalishlarini belgilash, o'quv rejalari va dasturlarini tasdiqlash hamda pedagog xodimlarning mehnatini me'yorlashtirish;

yuqori malakali, jumladan xorijiy mamlakatlardagi yetuk mutaxassislarni jalb etish, ularga mehnat bozorining amaldagi

The University has a seal with the image of the State Emblem of the Republic of Uzbekistan and its name in the state language, bank accounts, a stamp and other details.

2. Define the main objectives of the University:

training of promising, internationally competitive personnel with deep modern professional knowledge and high qualifications, based on the educational programs of prestigious foreign higher education institutions;

organization of the educational process based on educational technologies and methods implemented in the world's leading universities using advanced pedagogical and modern information technologies;

the formation of a comprehensively favorable educational environment that promotes the development of intellectual abilities, strengthening students' knowledge through the instillation of practical experience, as well as the effective and thorough mastery of educational material;

conducting scientific research, implementing close cooperation with prestigious and recognized scientific centers of foreign countries, widely involving students in scientific and innovative activities, based on existing needs in the socio-economic spheres;

providing methodological assistance to Presidential, creative and specialized schools in order to ensure the continuity and quality of education.

3. Determine that:

a) The University independently:

approves the structure and staffing schedule of the University, establishes the procedure for studying in the bachelor's and master's degrees;

konyunkturasini hisobga olgan holda Universitet xodimlarining ish haqi va boshqa to'lovlar miqdorini belgilash; bakalavriat, magistratura va doktoranturaga qabul qilish shartlarini, shuningdek, talabalarni qabul qilishda test sinovlari fanlari majmuasini va o'qish uchun to'lov miqdorini belgilash; innovatsiya va ilmiy faoliyatni olib borish, ilm-fan yutuqlarini tijoratlashtirish hamda moliyaviy resurslarni jalb etish uchun tijorat va notijorat tashkilotlar (startap, jamg'arma va boshqalar) tuzish; xorijiy ta'lim va ilmiy tashkilotlar bilan to'g'ridan-to'g'ri muzokaralar olib borish hamda o'z faoliyatiga oid moliyaviy-iqtisodiy va ma'muriy boshqaruv yuzasidan qarorlarni qabul qilish; b) Universitetda ta'lim-tarbiya jarayonlari milliy va umuminsoniy qadriyatlar asosida olib boriladi hamda talabalarda yuksak ma'naviy va axloqiy fazilatlarini rivojlantirish, Vatanga muhabbat va sadoqat, xalq manfaatlari uchun xizmat qilish tuyg'usi bilan yashaydigan barkamol avlod sifatida tarbiyalashga xizmat qiladi; v) Universitetda ta'lim jarayoni 2021/2022 o'quv yilidan boshlanadi hamda davlat va ingliz tillarida, kredit-modul tizimi asosida olib boriladi; g) Universitetda ta'lim jarayoni davlat granti va to'lov-kontrakt asosida amalga oshiriladi; d) talabalarni qabul qilish parametrlari Maktabgacha va maktab ta'limi vazirligi huzuridagi Ixtisoslashtirilgan ta'lim muassasalari agentligi (keyingi o'rinlarda — Agentlik) bilan kelishgan holda Universitet tomonidan o'rnatiladi; e) Universitetda uning ilmiy salohiyatidan kelib chiqib, ilmiy va ilmiy-pedagogik kadrlar tayyorlash yo'lga qo'yiladi;	determines the directions of education on the basis of agreements concluded with foreign higher education organizations, approves curricula and programs, and carries out labor standards for teaching staff; attracts highly qualified specialists, including experienced specialists from foreign countries, sets their wages and other payments taking into account the current situation on the labor market at the level of University employees; establishes the conditions for admission to bachelor's, master's and doctoral programs, as well as the block of subjects for testing when admitting students and the amount of tuition fees; carries out innovative and scientific activities, as well as the commercialization of scientific achievements, creates commercial and non-commercial organizations (startups, funds, and others) to attract financial resources; conducts direct negotiations with foreign educational and scientific organizations, and also makes decisions on issues of its financial, economic, and administrative and managerial activities; b) at the University, the processes of education and upbringing are carried out on the basis of national and universal human values, which contribute to the instillation of high spiritual and moral qualities, as well as the education of students as a harmoniously developed generation living with a sense of love and devotion to the Motherland, serving the interests of the people; c) at the University, the educational process begins in the 2021/2022 academic year and is conducted in the state and English languages on the basis of a credit-modular system; d) at the University the educational process is carried out on the basis of a state grant and a paid contract;

j) Universitetda ta'lim jarayoni "fan - ta'lim - ishlab chiqarish integratsiyasi" tamoyili asosida tashkil etilib, talabalar 1-kursdan ishlab chiqarish va ilmiy-tadqiqot markazlariga biriktiriladi hamda bitiruvchi kurs talabalari uchun "El-yurt umidi" jamg'armasi hisobidan yetakchi xorijiy oliy ta'lim muassasalarida o'qishni davom ettirish va bitiruv oldi amaliyotini nufuzli xorijiy kompaniyalarda o'tash imkoniyati yaratiladi; z) Agentlik Universitetga malakali professor-o'qituvchilarni, jumladan xorijiy mamlakatlar mutaxassislarini jalb qilishga yaqindan ko'maklashadi; i) Universitet bitiruvchilariga O'zbekiston Respublikasida oliy ma'lumot to'g'risidagi hujjat sifatida tan olinadigan Universitet tomonidan belgilangan namunadagi diplom beriladi; k) Universitetda talabalar bo'sh vaqtini mazmunli o'tkazishi uchun sport to'garaklari, san'at studiyalari, kutubxona va ekskursiyalar tashkil etiladi, turli trening va madaniy uchrashuvlar o'tkaziladi. 4. Universitetda iqtidorli talabalarning ta'lim olishini qo'llab-quvvatlash uchun davlat granti quyidagilarga nisbatan tatbiq etiladi: xalqaro darajadagi tegishli dasturlar (International Baccalaureate, Advanced Placement, International Advanced Levels) diplomi yoki sertifikatiga ega Prezident maktablari bitiruvchilariga; Agentlik tizimidagi ijod va ixtisoslashtirilgan maktablar uchun ajratiladigan qabul parametrlariga muvofiq kirish imtihonlari asosida ushbu maktablar bitiruvchilariga; Universitetga kirish imtihonlaridan muvaffaqiyatli o'tgan Xalqaro matematika olimpiadasi (IMO), Xalqaro fizika olimpiadasi (IPhO), Xalqaro kimyo olimpiadasi (IChO), Xalqaro biologiya olimpiadasi (IBO), Xalqaro informatika olimpiadasi (IOI) g'oliblariga;	See previous edition. d) the parameters for student admission are established by the University in agreement with the Agency for Specialized Educational Institutions under the Ministry of Preschool and School Education (hereinafter referred to as the Agency); e) the University, based on its scientific potential, is establishing the training of scientific and scientific-pedagogical personnel; g) at the University the educational process is organized according to the principle of "integration of science – education – production"; starting from the first year, students are assigned to production and research centers; final-year students are given the opportunity, at the expense of the El-Yurt Umidi Foundation, to continue their education in leading foreign higher educational institutions and undergo pre-graduation practice in prestigious foreign companies; c) The Agency provides direct assistance in attracting qualified professors and teachers to the University, including specialists from foreign countries; i) graduates of the University are issued a diploma recognized as a document on higher education in the Republic of Uzbekistan, according to the model established by the University; k) in order to provide students with a meaningful way to spend their free time, the University organizes sports clubs, art studios, creates libraries, and also conducts excursions, various trainings and cultural meetings. 4. In order to support gifted students in obtaining an education at the University, the state grant applies to:

5. "Yangi O'zbekiston" universitetining faoliyatini yo'lga qo'yish bo'yicha "yo'l xaritasi" ilovaga muvofiq tasdiqlansin.

6. Agentlik tomonidan Universitetda ta'lim jarayonlarini xalqaro standartlar asosida tashkil etish bo'yicha Amerika Qo'shma Shtatlarining Massachusetts texnologiya instituti, Stenford universiteti, Buyuk Britaniyaning Kembrij universiteti, Germaniyaning Myunxen texnika universiteti va boshqa nufuzli xorijiy oliy ta'lim muassasalari bilan muzokaralar olib borilayotganligi ma'lumot uchun qabul qilinsin.

Agentlik:

a) bir oy muddatda:

Universitet ustavining tasdiqlanishi va uning davlat ro'yxatidan o'tkazilishini ta'minlasin;

muzokaralar yakuni bo'yicha hamkor xorijiy oliy ta'lim muassasalari bilan uzoq muddatli kelishuvga erishish choralari ko'rsin;

2021/2022 o'quv yilidan boshlab joriy etiladigan ta'lim yo'nalishlarini belgilasin;

b) ikki oy muddatda Universitetni chuqur bilim, yuqori kasb mahoratiga ega, tajribali rahbar va pedagog kadrlar hamda malakali mutaxassislar bilan to'ldirish choralari ko'rsin;

graduates of Presidential schools who have a diploma or certificate from the relevant international level programs (International Baccalaureate, Advanced Placement, International Advanced Levels);

graduates of creative and specialized schools of the Agency's system on the basis of entrance examinations in accordance with the admission parameters allocated for these schools;

winners of the International Mathematical Olympiad (IMO), International Physics Olympiad (IPhO), International Chemistry Olympiad (IChO), International Biology Olympiad (IBO), International Olympiad in Informatics (IOI), who successfully passed the entrance exams to the University;

citizens of the Republic of Uzbekistan who scored high marks in the entrance exams to the University;

children from families included in the information system "Unified Register of Social Protection" or the information module "Register of Poor Families" who have successfully passed the entrance exams to the University.

The Agency shall, within one month, submit to the Cabinet of Ministers a draft government decision providing for the procedure for providing a state grant.

5. To approve the "Roadmap" for organizing the activities of the New Uzbekistan University in accordance with the appendix .

6. Take note that the Agency is conducting negotiations on the organization of the educational process at the University based on international standards with the Massachusetts Institute of Technology, Stanford University in the United States of America, the University of Cambridge in the United Kingdom, the Technical University of Munich in Germany and other prestigious foreign higher education institutions.

11. Agentlik manfaatdor vazirlik va idoralar bilan birgalikda bir oy muddatda qonunchilik hujjatlariga mazkur qarordan kelib chiqadigan o‘zgartirish va qo‘shimchalar to‘g‘risida Vazirlar Mahkamasiga takliflar kiritsin.

funds received from business activities and provision of services on a contractual basis;

charitable donations from legal entities and individuals;

grants from international financial organizations;

other sources not prohibited by legislation.

The Cabinet of Ministers shall ensure, within one month, the allocation of funds necessary for the organization of the educational process at the University starting from the 2021/2022 academic year.

8.Exempt from customs duties until June 1, 2024, educational and scientific laboratory equipment, laboratory consumables, computer equipment, software and multimedia products, educational and scientific-methodological literature, construction materials, as well as inventory and material and technical resources imported by the Agency and the University.

9. At the request of the University:

The Ministry of Foreign Affairs of the Republic of Uzbekistan shall ensure, in accordance with the established procedure, the issuance of multiple entry visas to invited foreign teachers and specialists, as well as members of their families, without charging consular and other fees;

The Ministry of Internal Affairs of the Republic of Uzbekistan shall ensure, in accordance with the established procedure, the extension of multiple-entry visas for invited foreign teachers and specialists, members of their families, as well as temporary registration at their place of residence and its extension.

10. To the Cabinet of Ministers:

The Agency, together with interested ministries and departments, shall, within one month, submit to the Cabinet of Ministers proposals on amendments and additions to legislative acts arising from this resolution. 12. Control over the implementation of this resolution shall be assigned to the Prime Minister of the Republic of Uzbekistan A.N. Aripov and the Head of the Administration of the President of the Republic of Uzbekistan Z.Sh. Nizomiddinov.
