

**“Yangi O‘zbekiston” universitetining iqtidorli talabalariga davlat grantini berish tartibi to‘g‘risida**

NIZOM

**1-bob. Umumiy qoidalar**

1. Ushbu Nizom Maktabgacha va maktab ta’limi vazirligi huzuridagi Ixtisoslashtirilgan ta’lim muassasalari agentligi (keyingi o‘rinlarda — Agentlik) tizimidagi “Yangi O‘zbekiston” universitetining (keyingi o‘rinlarda — Universitet) bakalavriat ta’lim yo‘nalishlari va magistratura mutaxassisliklarida iqtidorli talabalarning ta’lim olishini qo‘llab-quvvatlash uchun davlat grantini berish tartibini belgilaydi.

2. Mazkur Nizomda quyidagi asosiy tushunchalar qo‘llaniladi:

**grant talabgori** — Universitetga o‘qishga qabul qilish bo‘yicha belgilangan tartibga muvofiq to‘liq davlat granti asosida o‘qishi belgilangan, shuningdek, kirish imtihonlaridan muvaffaqiyatli o‘tib, yuqori o‘rinlarni egallagan abituriyent hamda o‘quv yili yakuni bo‘yicha akademik ko‘rsatkichlari eng yuqori bo‘lgan talabalar;

**davlat granti** — O‘zbekiston Respublikasi Davlat budgeti mablag‘lari hisobidan Universitetda o‘qish qiymati qonunchilikda belgilangan tartibda qoplab beriladigan mablag‘ miqdori;

**stipendiat** — qonunchilikka muvofiq to‘liq yoki tabaqlashtirilgan tartibda davlat granti taqdim etilgan Universitet talabaları.

3. Universitetni tamomlagandan so‘ng Agentlik yo‘llanmasiga asosan egallagan mutaxassisligi bo‘yicha mulkchilik shakllaridan qat‘i nazar respublikada faoliyat yurituvchi tashkilotlarda 5 yilgacha to‘liq bandlik rejimida ishlab berish majburiyatini o‘z zimmasiga olgan O‘zbekiston Respublikasi fuqarosi yoki O‘zbekiston Respublikasi hududida doimiy

**REGULATION  
on the Procedure for Awarding State Grants to Talented Students of  
New Uzbekistan University**

**Chapter I. General Provisions**

1. This Regulation defines the procedure for awarding state grants in support of education for talented students enrolled in undergraduate and graduate programs at New Uzbekistan University (hereinafter – the University), which operates under the Agency for Specialized Educational Institutions under the Ministry of Preschool and School Education of the Republic of Uzbekistan (hereinafter – the Agency).

2. The following key terms are used in this Regulation:

*Grant applicant* – a candidate who is eligible for full state-funded education at the University in accordance with the established admission procedures, including applicants who have successfully passed the entrance examinations and ranked among the highest scorers, as well as current students with the highest academic performance by the end of the academic year;

*State grant* – a financial amount provided to cover tuition fees at the University from the State Budget of the Republic of Uzbekistan, in accordance with the procedures established by law;

*Grant recipient (stipendiat)* – a student of the University who has been awarded a full or differentiated state grant in accordance with applicable legislation.

3. A citizen of the Republic of Uzbekistan, or a stateless person permanently residing in the territory of the Republic of Uzbekistan, who undertakes the obligation to work in a full-time capacity for up to five years in an organization operating in the Republic—regardless of ownership—

yashab turgan fuqaroligi bo‘lmasan shaxs davlat granti talabgori bo‘lishi mumkin.

4. Universitetda iqtidorli talabalarning ta’lim olishini qo‘llab-quvvatlash uchun davlat granti:

xalqaro darajadagi tegishli dasturlar (International Baccalaureate, Advanced Placement, International Advanced Levels) diplomi yoki sertifikatiga ega Prezident maktablari bitiruvchilariga;

Agentlik tizimidagi ijod va ixtisoslashtirilgan mакtablar uchun ajratiladigan qabul parametrlariga muvofiq kirish imtihonlari asosida ushu mакtablar bitiruvchilariga;

Universitetga kirish imtihonlaridan muvaffaqiyatlari o‘tgan Xalqaro matematika olimpiadasi (IMO), Xalqaro fizika olimpiadasi (IPhO), Xalqaro kimyo olimpiadasi (IChO), Xalqaro biologiya olimpiadasi (IBO), Xalqaro informatika olimpiadasi (IOI) g‘oliblariga;

Universitetga kirish imtihonlarida yuqori ball to‘plagan O‘zbekiston Respublikasi fuqarolariga;

Universitetga kirish imtihonlaridan muvaffaqiyatlari o‘tgan “Ijtimoiy himoya yagona reyestri”ga kiritilgan oilalar farzandlariga nisbatan taqdim etiladi.

5. Davlat granti Universitetning bakalavriat ta’lim yo‘nalishlari va magistratura mutaxassisliklari bo‘yicha kunduzgi ta’lim shaklida tahlil oladigan grant talabgorlari uchun ajratiladi.

6. Davlat granti mazkur Nizomga ilovada keltirilgan sxemaga muvofiq taqdim etiladi.

7. Grant talabgorlari bo‘lgan abituriyentlar Universitetga qabul bo‘yicha belgilangan tartibda onlayn platforma orqali ariza bilan birga hujjalarni taqdim etish jarayonida mazkur Nizomning 4-bandida ko‘rsatilgan grant talabgorlari toifasiga tegishli ekanligini tasdiqlovchi hujjalarning PDF

according to the specialization obtained upon graduation from the University and in accordance with the assignment of the Agency, may qualify as a grant applicant.

**4. State grants in support of education at the University may be awarded to the following categories:**

Graduates of Presidential Schools who hold diplomas or certificates from relevant international programs (International Baccalaureate, Advanced Placement, International Advanced Levels);

Graduates of creative or specialized schools under the Agency, based on entrance examinations and admission quotas established for such schools;

Winners of the International Mathematical Olympiad (IMO), International Physics Olympiad (IPhO), International Chemistry Olympiad (IChO), International Biology Olympiad (IBO), and International Olympiad in Informatics (IOI), who have successfully passed the University entrance examinations;

Citizens of the Republic of Uzbekistan who have achieved high scores in the University entrance examinations;

Applicants from families listed in the “Unified Register of Social Protection” who have successfully passed the University entrance examinations.

**5. The state grant is allocated to grant applicants enrolled in full-time undergraduate and graduate programs at the University.**

**6. The state grant shall be awarded in accordance with the scheme provided in the annex to this Regulation.**

**7. During the application process through the online platform, grant applicants must submit scanned PDF copies of documents confirming their eligibility under the categories outlined in paragraph 4 of this Regulation, except for citizens of Uzbekistan who have achieved high entrance exam**

(portable document format) formatida skaner qilingan nuxxalarini ham ilova qiladi, Universitetga kirish imtihonlarida yuqori ball to‘plagan O‘zbekiston Respublikasi fuqarolari bundan mustasno.

Ushbu hujjatlar abituriyentlar tomonidan Universitetga qabul qilish bo‘yicha arizalarga belgilangan muddatlarda taqdim etilishi shart. Qabul qilish muddati tugagandan so‘ng hujjatlarga o‘zgartirish va qo‘srimchalar kiritilmaydi.

8. Davlat grantini olish uchun alohida ariza topshirilmaydi.

#### **2-bob. Davlat grantini ajratish tartibi**

9. Davlat granti Universitet tomonidan har bir bakalavriat ta’lim yo‘nalishi va magistratura mutaxassisligi uchun belgilangan qabul kvotasi doirasida Agentlik bilan kelishilgan holda ajratiladi.

10. Davlat grantining to‘liq (100 foiz) miqdori Universitetda bakalavriat ta’lim yo‘nalishi va magistratura mutaxassisligi bo‘yicha belgilangan to‘lov-kontraktning to‘liq (100 foiz) miqdoriga teng bo‘ladi.

11. Quyidagi toifaga kiruvchi grant talabgoriga to‘liq (100 foiz) miqdorda davlat granti ajratiladi:

a) xalqaro darajadagi tegishli dasturlar (International Baccalaureate, Advanced Placement, International Advanced Levels) diplomi yoki sertifikatiga ega Prezident maktablari bitiruvchilari;

b) Universitetga kirish imtihonlaridan muvaffaqiyatli o‘tgan:

Xalqaro matematika olimpiadasi (IMO), Xalqaro fizika olimpiadasi (IPhO), Xalqaro kimyo olimpiadasi (IChO), Xalqaro biologiya olimpiadasi (IBO), Xalqaro informatika olimpiadasi (IOI) g‘oliblari;

bakalavriat ta’lim yo‘nalishlari va magistratura mutaxassisliklari bo‘yicha belgilangan umumiy qabul kvotalarining 5 foizi miqdorida

scores. These documents must be submitted within the admission deadlines set by the University. After the deadline, no amendments or additions to the submitted documents will be accepted.

8. A separate application for the state grant is not required.

#### **Chapter II. Procedure for the Allocation of State Grants**

9. State grants shall be allocated by the University within the admission quotas established for each undergraduate program and graduate specialization, in coordination with the Agency.

10. The full (100%) amount of the state grant shall be equal to the full (100%) amount of the tuition fee established for undergraduate and graduate programs at the University.

11. A full (100%) state grant shall be awarded to applicants who fall under the following categories:

a) Graduates of Presidential Schools who hold diplomas or certificates from relevant international programs (International Baccalaureate, Advanced Placement, International Advanced Levels);

b) Applicants who have successfully passed the University entrance examinations and are winners of the:

International Mathematical Olympiad (IMO),

International Physics Olympiad (IPhO),

International Chemistry Olympiad (IChO),

International Biology Olympiad (IBO),

International Olympiad in Informatics (IOI);

ajratilgan kvota bo'yicha o'qishga qabul qilingan Agentlik tizimidagi ijod va ixtisoslashtirilgan maktablar bitiruvchilari;

"Ijtimoiy himoya yagona reyestri"ga kiritilgan oilalar farzandlari.

Agentlik tizimidagi ijod va ixtisoslashtirilgan maktablar bitiruvchilari uchun belgilangan umumiy qabul kvotalarining 5 foizi miqdorida ajratilgan qabul kvotasi doirasiga kirmagan Agentlik tizimidagi ijod va ixtisoslashtirilgan maktablar bitiruvchilari umumiy tartibda bakalavriat ta'lim yo'nalichlari va magistratura mutaxassisliklari bo'yicha davlat grantiga talabgorlik qilishlari mumkin.

12. Mazkur Nizomning 11-bandiga muvofiq davlat granti taqdim etilgan stipendiatlar uchun butun o'quv yillari mobaynida to'liq davlat grantini taqdim etish tartibi saqlab qolinadi.

Bunda stipendiatning o'quv yili (semestr) yakuniga ko'ra belgilangan akademik ko'rsatkichlari (Academic Performance) qoniqarsiz bo'lganligi natijasida talabaning tegishli fanni qayta o'qishi bilan bog'liq xarajatlar o'z hisobidan amalga oshiriladi.

13. Universitetga kirish imtihonlarida yuqori ball to'plagan O'zbekiston Respublikasi fuqarolari hamda o'tgan o'quv yili yakuniga ko'ra eng yuqori akademik ko'rsatkichlarga (Academic Performance) erishgan Universitet talabalariga (ushbu Nizomning 11-bandida ko'rsatilgan grant talabgorlaridan tashqari) davlat granti bir o'quv yili uchun quyidagi jadvalga muvofiq tabaqlashtirilgan tartibda ajratib beriladi:

c) Graduates of creative and specialized schools under the Agency who are admitted under a quota constituting 5% of the total admission quota established for undergraduate and graduate programs;

d) Children of families included in the "Unified Register of Social Protection."

Graduates of creative and specialized schools under the Agency who are not admitted within the 5% quota specified above may still apply for state grants in undergraduate and graduate programs under the general procedure.

**12.** Grant recipients covered under paragraph 11 of this Regulation shall continue to receive the full state grant throughout the entire duration of their academic program.

In such cases, however, if a student fails to achieve satisfactory academic performance (as defined by the University) at the end of the academic year or semester and is required to retake a subject, the related expenses must be covered by the student personally.

**13.** Citizens of the Republic of Uzbekistan who achieve high scores in the University entrance examinations, as well as current University students who demonstrate the highest academic performance based on the results of the previous academic year (excluding those covered under paragraph 11 of this Regulation), may be awarded differentiated state grants for one academic year in accordance with the following table:

The allocation of differentiated state grants shall be reviewed annually by the University based on the established criteria and shall be awarded to eligible applicants in accordance with the prescribed procedure.</p> <p>15. Applicants (students) who fall into Groups 2 and 3 of the differentiated state grant allocation table shall be responsible for paying the remaining portion of the tuition fee, as specified in the student contract, within the established deadlines.</p> <p>16. In cases where two or more applicants have received equal scores, the state grant shall be awarded to all such applicants with equal scores.</p> <p>17. ### **3-bob. Davlat grantini moliyalashtirish**

18. O‘zbekiston Respublikasi Davlat budjeti mablag‘lari hisobidan davlat grantini berish xarajatlari uchun mablag‘lar O‘zbekiston Respublikasi respublika budgetidan birinchi darajali budjet mablag‘larini taqsimlovchi sifatida Ixtisoslashtirilgan ta’lim muassasalari agentligiga ajratiladigan mablag‘larning cheklangan miqdorlari doirasida nazarda tutiladi.

O‘zbekiston Respublikasi respublika budgetidan davlat grantini berish xarajatlari uchun ajratiladigan mablag‘lar Agentlikning Moliya vazirligi G‘aznachiligidagi ochilgan alohida shaxsiy g‘azna hisobvarag‘ida nazarda tutiladi.

19. Agentlik belgilangan tartibda tuzilgan uch tomonlama shartnomaga muvofiq har o‘quv yili boshlanishining birinchi o‘n besh ish kuni mobaynida Universitetning bank hisobvarag‘iga tegishli mablag‘larni moliyalashtirib beradi.

20. O‘zbekiston Respublikasi respublika budgetidan Agentlikka davlat grantini berish xarajatlari uchun ajratiladigan mablag‘lar bo‘yicha xarajatlar smetasini tuzish, tasdiqlash, ro‘yxatdan o‘tkazish va unga o‘zgartirishlar kiritish budjet qonunchiligidagi belgilangan tartibda amalga oshiriladi.

### **4-bob. Grant talabgorlarining huquq va majburiyatları**

21. Quyidagilar grant talabgorlarining huquqlari hisoblanadi:

kirish imtihonlarida eng yuqori o‘rinlarni egallagan va o‘quv yili yakunidagi akademik ko‘rsatkichlaridan (Academic Performance) kelib chiqib davlat grantini to‘liq yoki qisman belgilangan tartibda olish;

Universitetda to‘lov-kontrakt asosida o‘qigan holda keyingi o‘quv semestrlari yakuni bo‘yicha akademik ko‘rsatkichlari (Academic Performance) yuqori bo‘lgan taqdirda, davlat grantiga talabgor bo‘lish;

### **Chapter III. Financing of the State Grant**

**18.** The expenses for awarding state grants shall be covered from the funds of the State Budget of the Republic of Uzbekistan within the limits of the allocated funds provided to the Agency for Specialized Educational Institutions as a first-level budget administrator from the republican budget of the Republic of Uzbekistan.

The funds allocated from the republican budget of the Republic of Uzbekistan for the expenses related to awarding state grants shall be credited to a separate treasury account of the Agency opened with the Treasury of the Ministry of Finance.

**19.** In accordance with the tripartite agreement concluded in the prescribed manner, the Agency shall transfer the relevant funds to the University’s bank account within the first fifteen working days of the academic year.

**20.** The preparation, approval, registration, and amendment of the expenditure estimates for the funds allocated to the Agency from the republican budget of the Republic of Uzbekistan for the purpose of awarding state grants shall be carried out in accordance with the procedures established by the budget legislation.

### **Chapter IV. Rights and Obligations of Grant Applicants**

**21.** The following shall be considered the rights of grant applicants:

To receive a full or partial state grant, in accordance with the established procedure, based on their top-ranking results in entrance examinations and academic performance at the end of the academic year;

To become eligible for a state grant in subsequent academic semesters if they are studying at the University on a tuition-contract basis and demonstrate high academic performance (Academic Performance);

22. To‘liq davlat granti asosida ta’lim olgan bitiruvchilarga (stipendiatslarga) o‘qishni tamomlagandan so‘ng, biroq ikki oy muddatdan kechikmasdan Agentlik yo‘llanmasiga asosan egallagan mutaxassisligi bo‘yicha mulkchilik shakllaridan qat‘i nazar respublikada faoliyat yurituvchi tashkilotlarda 5 yilgacha to‘liq bandlik rejimida ishlab berish majburiyati yuklanadi.

Davlat tashkilotlarida kadrlarga bo‘lgan ehtiyoj Bandlik va mehnat munosabatlari vazirligi tomonidan aniqlanadi hamda davlat granti sohibi bo‘lgan bitiruvchilarni taqsimlash uchun Agentlikka taqdim etiladi.

O‘qish davrida davlat grantini qisman olgan bitiruvchilarning davlat granti umumlashtirilib, majburiy ishlab berish muddati mutanosib ravishda, biroq kamida bir yilgacha bo‘lgan muddatga yaxlitlanib hisoblanadi.

23. Magistratura bosqichida yoki doktoranturada o‘qishni davom ettirayotgan Universitet bakalavriat yoki magistratura bosqichi bitiruvchilarining (stipendiatslarning) majburiy ishlab berish muddati magistratura bosqichida yoki doktoranturada o‘qish davri tugagandan so‘ng boshlanadi.

24. Davlat granti asosida ta’lim olgan bitiruvchi (stipendiat) mazkur Nizomda hamda shartnomada belgilangan majburiyatlarni bajarmagan taqdirda, unga ajratilgan davlat grantining qiymati belgilangan tartibda O‘zbekiston Respublikasi Davlat budgetiga qaytariladi.

#### **5-bob. Yakunlovchi qoidalar**

25. Ushbu Nizomni qo‘llashda yuzaga keladigan nizolar qonunchilik hujjalarda belgilangan tartibda hal etiladi.

26. Ushbu Nizom talablarining buzilishida aybdor bo‘lgan shaxslar qonunchilik hujjalarda belgilangan tartibda javob beradilar.

To voluntarily decline the state grant and continue their studies at the University on a tuition-contract basis.

22. Graduates (stipendiats) who have studied under a full state grant are required, after completing their studies, but no later than within two months, to work full-time for up to five years in organizations operating in the Republic of Uzbekistan—regardless of the form of ownership—according to their specialization and based on an assignment issued by the Agency.

The demand for specialists in state institutions shall be determined by the Ministry of Employment and Labor Relations and submitted to the Agency for distribution of graduates who have received state grants.

For graduates who received partial state grants during their studies, the total amount of the received grants shall be consolidated, and the mandatory work period shall be proportionally calculated but not less than one year.

23. For University graduates (stipendiats) who continue their studies at the master’s or doctoral level, the mandatory work period shall commence after the completion of their studies at the master’s or doctoral level.

24. If a graduate (stipendiat) who studied under a state grant fails to fulfill the obligations specified in this Regulation or the Agreement, the amount of the state grant provided to them shall be subject to reimbursement to the State Budget of the Republic of Uzbekistan in accordance with the established procedure.

#### **Chapter V. Final Provisions**

25. Disputes arising in the application of this Regulation shall be resolved in accordance with the procedures established by the legislation.

26. Persons found responsible for violating the provisions of this Regulation shall be held accountable in the manner prescribed by law.
